ACFIM posted significant progress on the following four strands:

- Advocacy on developing a comprehensive campaign finance law in accordance with international good practices such as mandatory public disclosure of campaign income and reporting on expenditure.
- Public awareness on the vice of commercialised electoral politics which potentially provides fertile ground for political corruption to thrive.
- Citizenry mobilised on the importance of political accountability as a means of getting political leaders to focus more on the interests and needs of the electorate.

ACFIM recognises that improving transparency and accountability in political financing is one of the essential building blocks for democratising Uganda.

ACFIM aims at making a solid contribution towards Uganda's democratisation process by promoting transparency and accountability in political financing through monitoring, civic engagement and policy advocacy. To achieve that, in 2019 we:



Monitored campaign spending in 1 District by-election and 4 Tertiary Institutions



Youth trained and deployed on Campaign Finance Monitoring, research, and carrying out anti vote buying campaigns



Launched a Study Report that profiled the impact of commercialized electoral politics on electoral participants and took public debate to a new level.





Over 1,000 men and women participated in the two larger than life national symposiums on money in politics as a barrier to the democratization process.



256 Members of Parliament interacted directly with the project advocacy for campaign finance legislation. ACFIM ceased opportunity that came with the electoral amendment bills



127 Religious Leaders interacted directly with ACFIM on curbing commercialized attitudes of the electorate, i.e.: 37 Bishops from Church of Uganda, 38 clergy and lay leaders from catholic church, 52 district Khadi



PRIORITY AREA 1:

Monitoring Political Financing

This strategic priority area focuses on monitoring, documenting and exposing political party and candidate spending on election campaigns; misuse of state resources on election campaigns; and other forms of corruption in campaign financing namely, voter bribery. Findings are used to inform advocacy for campaign finance legislation.



1.1 By-elections and Guild Elections Monitored

During the year under review, ACFIM documented and disseminated the reports on the by-election of Nebbi District LC5 Chairperson, and student guild elections in four tertiary institutions namely; Makerere University (MAK), Kyambogo University (KYU), Uganda Christian University (UCU) and Makerere University Business School (MUBS).

ACFIM's understanding of the extent of commercialisation of elections in local government elections and in students' guild was deepened.

It is deeply ingrained in the university's political culture of Makerere University that when candidates aspiring for guild president visit halls of residence, they are confronted with 4-6 boxes laid on the table at the entrance, and they must put money in every box lest they are denied entry into the hall of residence to campaign. These boxes include among others; culture box, elders' box, charity box, finance box and security box among others.

1.2 Increased Evidence-based Information on Political Finance

Campaign Finance Monitoring findings often trigger further studies to probe emergent phenomena. The studies have enhanced public awareness about the vice of commercialised electoral politics in the country.

During the period under review, ACFIM commissioned three studies of which one was completed and launched. These were namely;

- 1. Unregulated Campaign Spending and Its Impact on Electoral Participants
- 2. Commercialisation of Politics and Captivity of State Institutions in Uganda
- 3. The Nexus between Electoral Campaign Spending and Electoral Violence

PRIORITY AREA 2:

Civic Engagement for Political and Electoral Accountability



Under this priority area, ACFIM purposes to enhance political and electoral accountability through civic engagement with political leaders, and empowerment of citizens to make rational electoral decisions.

2.1 ACFIM has increased citizen awareness about commercialisation of Politics as an Impediment to Democratisation

The second National Symposium of Money in Electoral Politics attracted over 900 participants. Renowned Kenyan jurist and Pan African, Professor PLO Lumumba was the Keynote speaker. Lumumba's presentation was discussed his Uganda's own Pan African scholars, Professor Kihura Nkuba, and

2.2 Increased Youth Participation in Discourse on Commercialisation of Electoral Politics and its Impeding effect on Democratisation

ACFIM recognises that the efforts to curb commercialised electoral politics may not be successful if the role of the youth is either minimal or missing out in the equation. As such youth from 20 tertiary institutions participated in the second Youth

Convention on Money in Politics. The convention was hosted by Uganda Christian University at their main campus in Mukono. The theme for the convention was "Commercialised politics as a barrier to youth participation in national development."

Participating institutions included Makerere University Kampala (MUK), Makerere University Business School, Kyambogo University, Kampala International University, Uganda Christian University, Ndejje University, Nkumba University, Multitech Business School, Islamic University in Uganda, Muteesa I Royal University, St. Lawrence University, University of Kisubi (UNIK), International University of East Africa and Cavendish University.

2.3 Increased civic awareness through Forum Theatre

Over 5,000 citizens at grass root level in Greater Luweero and Greater Masaka sub-regions, sensitised on how commercialized electoral politics directly affects public service delivery and their quality of living. The civic engagement events were strategically stationed in urban centres where it was easier to draw a crowd of people.

ACFIM worked with two of her partner organisations namely Citizens Platform for Democracy and Accountability that uses Forum Theatre as one of her civic engagement strategies; and Community Development and Child Welfare Initiatives (CODI) which works in Greater Luweero sub-region. The activity was successful in taking the discussion on commercialised electoral politics to the people who experience vote buying directly from candidates.

PRIORITY AREA 3:

Campaign Finance Reforms Prioritised

Under this priority area, ACFIM purposed to engage policy makers on enactment of a standalone campaign finance law or at the very least amend the electoral laws, to incorporate campaign finance provisions, toughen provisions on voter bribery, donations during election period and involvement of public officers in political campaigns.

3.1 Debate on Campaign Finance Provisions to be or not be anchored in electoral laws reached the floor of Parliament for the First time in the legislative history of Uganda.

Following a series of formal and informal ACFIM engagements with the Electoral Commission, Office of the First Parliamentary Council and the policy department of the Ministry of Justice and Constitutional Affairs, government included the campaign finance provisions in the five electoral amendment laws that were tabled in Parliament in July 2019, by the Attorney General.

ACFIM went further to engage strategically with the members of the sessional committee on Legal and Parliamentary Affairs both at sub national level when they

carried out nationwide consultations. At national level ACFIM and the broader civil society fraternity engaged the committee when it opened up for public hearings. The committee report which was presented to Parliament for the second reading reinforced the campaign provisions and also rubberstamped ACFIM's position of a standalone election campaign finance law. During the 3rd reading in the parliament, the provisions were dropped mysteriously.

Nonetheless, ACFIM had engaged widely with varied caucuses in the 10 Parliament as presented in the following photographs.




